O R D E R

Application for impleadment (IA No. 111906/2019) is allowed.

During the course of hearing these appeals, we have been apprised of the fact that large-scale amendments have been made to the Insolvency and Bankruptcy Code, 2016, which has been passed by both Houses of Parliament.

Learned counsel appearing on behalf of the respondents take umbrage at some of these provisions, and seek to challenge some provisions of the new Amendment Act. Writ Petitions challenging the aforesaid provisions may be filed within a period of one week from today.

Registry is directed to list these matters along with the said Writ Petitions on Monday, the 19th August, 2019.

Parties are at liberty to give notice to the Union of India. We request the learned Attorney General for India to appear on Monday, the 19th August, 2019 in order that directions be passed with regard to further hearing of these matters.
